### Section 2 - Hazard Identification

**Emergency Overview:** DANGER - Highly flammable. Harmful if swallowed.

**Eyes** - In case of contact with eyes, rinse immediately with plenty of water and seek medical advice.

**Skin** - After contact with skin, take off immediately all contaminated clothing, and wash immediately with plenty of water.

**Ingestion** - If swallowed, do not induce vomiting; seek medical advice immediately and show this container or label.

**Inhalation** - In case of accident by inhalation: remove casualty to fresh air and keep at rest.

**Precautions to Take in Handling or Storing:** Bond and ground containers when transferring liquid.

Keep away from sources of ignition - No smoking. Keep container tightly closed in a cool, well-ventilated place.

This material should be kept in an area suitable for the storage of flammable liquids. Store away from oxidizing agents, sparks and flame.
